# Supplementary food for dogs (digest)

#### 1. Description

OptiPal DP2050 is a highly palatable additive for improving the taste and aroma of dry dog food. OptiPal DP2050 is produced from fresh poultry liver and heat- and enzyme-treated poultry meat derivatives (poultry intestines) (animal by-products cat. 3 according to EP and Council Regulation 1069/2009).

#### 2. Ingredients

Poultry liver, poultry intestines. Phosphoric acid (E338), citric acid (E330), potassium sorbate (E202), BHA (E320), PG (E310). All raw materials used in the production of the etchings are classified as Category 3 material according to EU Regulation (EC) No 1069/2009.

## 3. Application

1-4% depending on the diet formulation and the desired results. The best effect can be obtained by using the product after coating with fat. The product should not be heated to above 45°C before spraying.

## 6. Storage and handling

For best results, the product should not be stored continuously in sub-zero temperatures or near heat sources. The product should be stored at ambient temperature, in a dark and dry place. The optimum temperature is 20°C. Do not allow the product to be stored for long periods in direct sunlight or at temperatures above 25°C. Best used within 6 months of production date. If stored at higher temperatures, natural separation may occur - gentle mixing before use is recommended to maintain homogeneity. Use the 1000 I IBC container to the end of its life after opening. In case of repeated use

(especially via the top fill), observe hygiene rules (disinfect cap and thread) to avoid secondary contamination.
